## 1. Introduction

These Terms & Conditions ("Terms") govern all photography services provided by Little Darlings Photography ("we", "us", "our"). By booking a session, you agree to these Terms.

## 2. Booking & Payment

- A booking is confirmed once a deposit is received.
- We require a £10 deposit.
- Deposits are non-refundable unless we cancel the session.
- The deposit is to secure the date and time
- The remaining balance is due the day before your session.
- We reserve the right to cancel your booking if payment is not received.

## 3. Cancellations & Rescheduling

- You may reschedule your session with at least 48 hours' notice and we will always try to be as accommodating as possible.
- Cancellations within this period may result in loss of deposit.
- In the event of illness (especially for children), we will always try to reschedule where possible.
- If we need to cancel due to unforeseen circumstances, a full refund or reschedule will be offered

## 4. Session Details

- Please arrive on time. Late arrival may reduce your session time if someone is booked after you.
- We are not responsible for uncooperative behaviour from children, though we will always work patiently to get the best possible results.
- We will always try to get the best images and a variety of images for you, but we can only capture what the children allow.
- You are responsible for supervising children at all times during the session.

## 5. Image Delivery

- Galleries will be delivered within 2-3 weeks, you will be notified within writing if this changes
- Images are delivered via an password protected online gallery unless otherwise agreed.
- RAW/unedited images are not provided.

- By booking, you agree to our editing style and creative approach.

- You are granted a personal-use licence to download, print, and share your images.
- Images must not be altered, edited, or used for commercial purposes without written permission.

## 8. Model Release

- Images may be used for portfolio, website, and social media marketing.
- You can opt out of this at any time by notifying us in writing.

## 9. Liability

- We take the utmost care in providing services and handling your images.
- In the unlikely event of loss, damage, or failure to deliver images, liability is limited to the amount paid.
- We are not liable for circumstances beyond our control (e.g. illness, weather, equipment failure).

- We are not liable for any accidents or injuries unless caused by negligence.
